- **Should Indiana Covid regulations prevent our anticipated gatherings, a virtual captains meeting, drive through weigh-in, and virtual awards ceremony may be required. This will be covered during registration as necessary.**
- Fishing period begins at 6:00 a.m.. No official stop time. Must be in line to weigh in at 2:00 p.m.

- **Entry is invalid if not signed and dated by each Captain.**

- I agree that I will follow applicable safety procedures to minimize any possible exposure and will abide by all Tournament protocols, such as social distancing, the use of protective face covering, and self-screening for symptoms during my participation in the Tournament.
- Failure to disclose or comply with any of the above could result in disqualification and forfeiture of entry fees.

Release and Waiver of Liability

I, hereby release, waive, and discharge the Tournament's Organizing Entities, their directors, officers, employees, and agents, from all liability to me, and covenant not to sue the Organizing Entities for any loss or damage, or any claim or demands on account of any damage, injury, including death, that I may experience as a result of contracting COVID-19, directly or indirectly, whether caused by ordinary negligence, active or passive, of the Organizing Entities or otherwise while I am participating in the Tournament.
